

Property Taxes – Caterpillar Inc.

Dear Mr. Mahon,

Thank you for writing to Springettsbury Township with your request for information in regards to “total taxes paid by Caterpillar Inc. for a property on Memory Lane, or any other properties in Springettsbury Township, for 2014, 2013, 2012, 2011, 2010, 2009, 2008, 2007, 2006, 2005, 2004 and 2003. I’m requesting taxes owed, taxes collected and any taxes that were not paid.”

Request Number 1 – Property on Memory Lane or any other properties in Springettsbury Township.

➤ Request Approved in Full:

- The Township records show that Caterpillar Inc. owns only the property referenced in your request as “Memory Lane Property” in Springettsbury Township.

Request Number 2 – Total taxes paid by Caterpillar Inc. for a property on Memory Lane for 2014, 2013, 2012, 2011, 2010, 2009, 2008, 2007, 2006, 2005, 2004 and 2003.

➤ Request Approved in Part and Denied in Part:


- The Township and County Taxes Paid in full for 2012 and 2013:
 - 2012 Total Paid Township and County \$125,449.80 (Township portion \$21,741.30).

- 2013 Total Paid Township and County \$134,696.10 (Township portion \$21,741.30).
- The Township and County Taxes Billed for 2014:
 - 2014 Total Billed Township and County \$140,760.00 (Township portion \$25,500.00). Payment can be made by June 16th without penalty.
- The School Taxes:
 - 2012 Total Billed and Paid \$528,162.12.
 - 2013 Total Billed and Paid \$525,792.12.
 - 2014 School Taxes are issued in August, therefore your request is denied.
 - Format of Report: Section 705: an agency shall not be required to create a record which does not currently exist or to compile, maintain, format or organize a record in a manner which the agency does not currently compile, maintain, format or organize the record.
- Request for the Township, County and School Taxes Billed and Payments for 2003 for 2011 is denied. The Township does not maintain the detailed tax collection records. These records would be held by the York County Tax Claim Bureau.
 - Format of Report: Section 705: an agency shall not be required to create a record which does not currently exist or to compile, maintain, format or organize a record in a manner which the agency does not currently compile, maintain, format or organize the record.
