

Thank you for writing to Springettsbury Township with your request for information in regards to "2960-3000 Whiteford Road."

The 8.2 Acre property is currently zoned C-H Commercial Highway. The property has been zoned in this manner since at least 1996.


A review of the Township records does not reveal any information regarding AST/UST, PCBs, spills/releases, petroleum and hazardous materials use, storage, or disposal activities, vapor intrusion, contaminated groundwater, solid waste disposal, asbestos, deed notices, or activity and use limitations at this location. Further, the Township does not have any record of any outstanding fire code violations at the property or, any records that the fire department has responded to the property for the purpose of cleaning up a release of hazardous materials. Finally, the Township has no records of the installation/removal of an AST/UST at the property.
