

"Please provide a total amount paid to the Law Firm of Blakey, Yost, Bupp, & Rausch for each year beginning in 2002 to present."


I reviewed the request and an extension of time to respond is required due to the reasons set forth below. The Township anticipates responding to your request no later than November 2, 2014.
