

The applicable fees associated with your request are unknown at this time. You will be advised of the estimated fees after completion of review of your request.



Dear Mr. Miller,

Thank you for writing to Springettsbury Township with your request for information in regards to:

“...right-of-way information for Wallace Street at the intersection with North Hills Road. I am working with PennDOT for the improvements at Exit 18 and 19 of I-83 and I am in need of this information to show the legal right-of-way widths for the streets.” and “...when and how the right-of-way was established.”

The Township has reviewed its records and found that the right-of-way width of Wallace Street is 50 feet. Resolution 68-51 indicates that it is unlawful for trucks to travel upon or use Wallace Street from its intersection with North Hills Road on the west and Dixie Drive on the east, except for the use of making local deliveries. The Township has no further records pertaining to when and how the right-of-way was established.


