

Re: **RIGHT-TO-KNOW REQUEST – Naloxone Use**

Dear Mr. Segelbaum,

Thank you for writing to Springettsbury Township with your request for information in regards to “I am requesting the police reports (and corresponding narrative sheets) for any and all instances in which the Springettsbury Township Police Department has used naloxone to revive someone. The date range I’m requesting these records for is from March 18, 2015 until the date this request is processed. If possible, I would like any and all responsible documents emailed to dsegelbaum@ydr.com.”

This request is denied for the following reason as expressed in the Right to Know Law:

1. Chapter 7, Section 708 (b) (5): A record of an individual’s medical, psychiatric or psychological history or disability status, including an evaluation, consultation, prescription, diagnosis or treatment; results of tests, including drug tests; enrollment in a health care program or program designed for participation by persons with disabilities, including vocation rehabilitation, workers’ compensation and unemployment compensation; or related information that would disclose individually identifiable health information.

This request is also denied for reasons expressed in the Health Insurance Portability and Accountability Act of 1996 (HIPAA) Privacy Rule.

You have a right to appeal denial of information in writing to Erik Arneson, Executive Director, Office of Public Records, Commonwealth Building, 400 North Street, 4th Floor, Harrisburg, PA 17120-0225.

If you choose to file an appeal, you must do so within fifteen business days of the mailing date of the agency’s response, as outlined in Section 1101 of the Right-To-Know Law.
