

ORDINANCE NO. 06-06

**AN ORDINANCE OF SPRINGETTSBURY TOWNSHIP, YORK
COUNTY, PENNSYLVANIA AMENDING SECTION 213-3 "RULES AND
REGULATIONS" OF CHAPTER 213 "PARKS AND RECREATION
AREAS" OF THE CODE OF
THE TOWNSHIP OF SPRINGETTSBURY**

NOW, THEREFORE, BE IT ENACTED AND ORDAINED by the Board of Supervisors of Springettsbury Township, York County, Pennsylvania, and **IT IS HEREBY ENACTED AND ORDAINED**, as follows:

SECTION 1. Section 213-3 "Rules and Regulations" of the Code of the Township of Springettsbury shall be modified and amended by the addition of the following:


- a) Section 213-3.B(19):
Skateboarding, in-line skating and bicycling are prohibited in all picnic shelters, on the tennis courts, and in the amphitheater area, including the stage, terrace seating area and designated access points.
- b) Section 213-3.B(23):
Smoking shall be prohibited at all times on any park property.

SECTION 2. This Ordinance shall be effective five (5) days from adoption.


