Dear Ms. Groff,

Thank you for writing to Springgettsbury Township with your request for:

“...statement that Officer John C. Shapley III told me to send Crystal Mumford a ‘no trespass’ letter on 4/20/2016 as she called him, in regards to me pulling up to her car & making a statement then in return she got out of her car & made a scene by coming back and yelling at me and yelling in front of neighbors’ homes I was told I was being charged for disorderly conduct, but in return I questioned why she wasn’t cited for road rage...”

The request is approved in part and denied in part.

A copy of the incident report, 3 pages, is available. The cost of the copy of the documents is 3 pages @ \$0.25 per page, or \$0.75 if picked up from the municipal office. Should you wish to have the information mailed, the additional cost is \$0.46 for a total cost of \$1.21.

If you choose to file an appeal, you must do so within fifteen business days of the mailing date of the agency's response, as outlined in Section 1101.
