My name is Christopher Dornblaser, reporter for the York Dispatch. Under the Pennsylvania Right to Know Law, 65 §66.1 et seq., I am requesting an opportunity to inspect or obtain copies of all the times the Springettsbury Township Police Department has responded to calls at the Walmart 2801 E Market St., for 2014, 2015, and 2016. I am looking for the nature of each call and how long the officer responded to each.

If there are any fees for searching or copying these records, please let me know. However, I would also like to request a waiver of all fees in that the disclosure of the requested information is in the public interest and will help people understand the impact the store might have on the township as well as the county as a whole.

The Pennsylvania Right to Know Law requires a response time within five business days. If access to the records I am requesting will take longer than this amount of time, please contact me with information about when I might expect copies or the ability to inspect the requested records.

If you deny any or all of this request, please cite each specific exemption you feel justifies the refusal to release the information and notify me of the appeal procedures available to me under the law.
