Dear Mr. Trott,

Thank you for writing to Springettsbury Township with your request for information. You have requested "Final Offer(s) of Employment for Chief Thomas Hyers. To include: salary, benefits, probationary period, work schedule, prospective raises, etc."

The information you requested was provided to you previously based on your Right-To-Know request dated April 27, 2012. This information was sent to you in correspondence from Mr. Charles Rausch, Township Solicitor, dated May 15, 2012:

- Page 2 Item 8: Conditional Offer of Employment dated 4/18/2012 (3 pages) (with redaction pursuant to Section 708(b)(6)(C)). "The Conditional Offer of Employment was signed by Chief Hyers and became the final offer of employment. There are no other offers of employment."

Your request is therefore denied for the following reason(s) under the Right-To-Know Law:

- Section 506(a)(1) An agency may deny a requester access to a record if the requester has made repeated requests for that same record and the repeated requests have placed an unreasonable burden on the agency.


