




I reviewed the request and an extension of time to respond is required due to the reasons set forth below. The Township anticipates responding to your request no later than October 25, 2012.

Dear Mr. Trott,

Thank you for writing to Springettsbury Township with your request for information.

Request #1.

Your request stated: "...provide the total amount spent by Springettsbury Township for legal fees/expenses for the period beginning January 1, 2000 to present. Please list amount for each year, which law firms were paid and how much."

Approved in Part and Denied in Part:

- > Reports have been redacted: Section 708(b)(6)(i)(A): A record containing all or part of a person's Social Security Number; driver's license number; personal financial information; home, cellular or personal telephone numbers; personal e-mail addresses; employee number or other confidential personal identification number.
- > Format of Report: Section 705: ...an agency shall not be required to create a record which does not currently exist or to compile, maintain, format or organize a record in a manner which the agency does not currently compile, maintain, format or organize the record.

Your request is approved as maintained by fund and by year. The cost of the copy of the documents is 35 pages @ \$0.25 per page, or \$8.75 if picked up from the municipal office. Should you wish to have the information mailed, the additional cost is \$2.10 for a total cost of \$10.85.



If you choose to file an appeal you must do so within fifteen business days of the mailing date of the agency's response, as outlined in Section 1101.
