



Thank you for writing to Springettsbury Township with your request for information in regards to:

 - The requested information is a noncriminal investigative report and is exempt under the law: Section 708 (b) (17).
 - The requested information is a criminal investigative report and is exempt under the law: Section 708 (b) (16).
 - Section 102 – Public record protected by the attorney work product privilege and the attorney-client privilege related to litigation.




