

The applicable fees associated with your request are unknown at this time. You will be advised of the estimated fees after completion of review of your request.



Thank you for writing to Springettsbury Township with your request for information in regards to "Copies of all pictures that the Township took of 1190 Graham Street from 2007 to present; all e-mail communications between DEP, Luciani, Conway, Gralski, Schenck between the dates of April 2011 to present relating to the 1190 Graham Street property and Darrah Motorsports; and any letters from First Capital to DEP pertaining to Darrah Motorsports.

Your request is approved for all pictures that the Township has on file of 1190 Graham Street from 2007 to present.

Your request for all e-mail communications between DEP, Luciani, Conway, Gralski, Schenck between the dates of April 2011 to present relating to the 1190 Graham Street property and Darrah Motorsports; and any letters from First Capital to DEP pertaining to Darrah Motorsports is approved in part and denied in part:

- The requested information is part of a noncriminal investigative report and is exempt under the law: Section 708 (b) (17).

- Section 102 – Public record protected by the attorney work product privilege and the attorney-client privilege related to litigation.


