



The applicable fees associated with your request are unknown at this time. You will be advised of the estimated fees after completion of review of your request.



Request #6: Your request for total Pension cost of Township for Chief Eshbach for 2009, 2010, 2011 is denied. The Springettsbury Township Police Pension, Death and Disability Fund is a defined benefit plan. All plan members and plan assets are pooled in order to determine an annual cost figure that must be paid by the Township. It is not possible to assign an exact cost to an individual pension plan member.

- **Format of Report: Section 705:** an agency shall not be required to create a record which does not currently exist or to compile, maintain, format or organize a record in a manner which the agency does not currently compile, maintain, format or organize the record.

The cost of reproduction of the documents is 2 pages @ \$0.25 per page, or \$0.50 if picked up from the municipal office. Should you wish to have the information mailed, the additional cost is \$0.46 for a total cost of \$0.96.


You have a right to appeal denial of information in writing to Terry Mutchler, Executive Director, Office of Public Records, Commonwealth Building, 400 North Street, 4<sup>th</sup> Floor, Harrisburg, PA 17120.

If you choose to file an appeal, you must do so within fifteen business days of the mailing date of the agency's response, as outlined in Section 1101 of the Right-To-Know Law.
