

Thank you for writing to Springettsbury Township with your request for information in regards to "...site plan, plot plan or land title survey..." for York Market Place, 2501 East Market Street.


I reviewed the request and an extension of time to respond is required due to the reasons set forth below. The Township anticipates responding to your request no later than May 31, 2013.
