Thank you for writing to Springettsbury Township with your request for the following information:

“Name, current contract including base salary, overtime, bonuses and fringe benefits for police chief of Springettsbury Township Police Department. Name of and all financial compensation paid to police chief of Springettsbury Township Police Department in 2017. Number of officers supervised by police chief of Springettsbury Township Police Department.”

Your request is approved. Please note, a prior letter was emailed to you on July 23 with the incorrect 2017 total compensation provided. The number provided in that letter was the 2016 total compensation. This letter provides the corrected information to the original request.

- Name of Springettsbury Police Chief: Daniel Stump
- 2017 Total Compensation: \$116,699.21
- There are a total of 32 officers including Chief Stump in Springettsbury’s Police Department.
- As a non-union employee, the Police Chief does not have a contract. This record does not exist and per Pennsylvania Right to Know Law, Act 3 of 2008, Section 705: *Creation of record. When responding to a request for access, an agency shall not be required to create a record which does not currently exist or to compile, maintain, format or organize a record in a manner in which the agency does not currently compile, maintain, format or organize the record.*
